Move to amend definition of ST on services 'unconstitutional'

RECHARGE & REBATE KARACHI: The Senate Assembly on Tuesday with a majority of 100 votes to 93 passed a resolution at amending the definition of sales tax or services in federal laws.

PML-N's leader, Iftikhar Khan Marwat was the only senator who opposed the move, saying that the treasury did not propose any amendment in the budget despite the opposition party's efforts to do so.

Majeed Ishaq, lawmaker of the Muttahida Qaumi Movement (MQM) party's support to the bill, however complained that the opposition had not provided any details on what changes it wanted to make in the law.

He said that the opposition had to be ready to face the consequences.

The opposition had proposed to withdraw the definition of sales tax on services in the Federal Budget 2013-14.

The government had proposed to increase the definition of sales tax on services.

Marwat said: "you want to withdraw the bill, do it like a joke of a bill," adding that copies of the resolution were withdrawn by the Federal

governments' side.

The resolution states: "This Senate resolves and recommends to the Government of Pakistan that the Government to withdraw the amendment proposed in the Federal Budget 2013-14 on the definition of sales tax on services."

National tax on services is a new concept introduced in the budget 2013-14.

It is reported that the amendment proposed by the Finance Services as proposed in the Federal Bill is because of the traditional

traditional school of thought.

Marwat said: "you want to withdraw the bill, do it like a joke of a bill," adding that copies of the resolution were withdrawn by the Federal

governments' side.

Before the article was passed, senators were asked to read it twice on it.

Finance Minister, Nisar Ahmed Khawaja said the resolution, which received support from 100 senators, was aimed at saving the country from financial difficulties.

He added the opposing legislation was not in favor to protect the financial rights.

In the meantime, Speaker of the Senate, Sadiq Sanjrani, suspended the session and called a sitting of the Senate "out of order" while it was raised the issue. The house then adjourned and resumed the budget discussions.
